

Approaches To Bridgetown - Admiralty Chart No: 502

Yachts approaching Barbados are requested to call the Signal Station on VHF Channel 12 and inform the Radio Operator of their intention. The Radio Operator will inform the Master whether permission is granted for him to enter the Deep Water Harbour directly on arrival or proceed to the Shallow Draught Berth. No yacht is to proceed to Carlisle Bay anchorage prior to clearing in with the regulatory agencies.

The Signal Station of the Deep Water Harbour lies in position latitude 13° 06' North, longitude 59° 38' West (at the northern extremity of Carlisle Bay) the latter of which provides good holding ground for anchorage and where the Careenage is situated for berthing small vessels and yachts. The characteristics of this light (No. 5811) are - flashing three red every ten seconds, visible twelve miles on a red and yellow mast fifteen meters above sea level.

The southern extremity of Carlisle Bay would be identified at night by a sector light (*No. 5807*) at Needham's Point, the characteristics of which are - flashing red every eight seconds, visible three miles and fixed on a red mast thirteen meters above sea level.

The Mole Head (entrance to Careenage) is identified by a light flashing red every ten seconds visible for two miles. It is fixed on a silver mast eight meters above sea level.



Deep Water Harbour

Having obtained permission to enter the Deep Water Harbour, the Yacht Master must keep in constant communication with the Signal Station on Channel 12 on VHF (call sign 8 PAPA BRAVO), so as to ensure that there is no other vessel maneuvering inside the Harbour. Enter at a safe speed and proceed to berth as assigned by the Signal Station.

N.B. The "Q" or Quarantine (yellow) flag must be hoisted immediately when the vessel is within the boundaries of the Harbour until she is cleared.

Customs Clearance Inwards And Outwards

Government has arranged for Health, Customs and Immigration Officers to be present at the Passenger Terminal, Bridgetown Harbour, from 0600 hours to 2200 hours, seven days per week for the purpose of entering and clearing yachts.

There are no additional fees for entering and clearing during the above hours.

Clearance for arrival and departure will be granted only in the Deep Water Harbour and at Port St. Charles.

Compulsory use of the recently developed national **Maritime Single Window** for full transition to electronic vessel clearance will be announced subsequently.




Documents Required For Inward Clearance

- (a) Customs
 - Three copies of "C61" Forms Clearance from the last Port of Call.
 - One copy of Crew List.
- (b) Immigration
 - Two copies of the Crew List.
 - All passports.
- (c) Health Officer
 - One copy of the Health Report.

Documents Required For Outward Clearance

- (a) Barbados Port Inc.
 - One copy of the Port Authority's Clearance.
- (b) Customs
 - One copy of the Outward Clearance.
 - One copy of the Crew List.
- (c) Immigration
 - One copy of the Crew List.
 - All passports.





CRUISING OR ANCHORING ALONG THE COAST

Please note the below definitions:

Anchorage: an area outside a harbor in which ships are permitted to drop an anchor to the bed of a body of water to prevent the craft from drifting due to wind or current.

Mooring: a permanent anchor outside, dropped in the water and equipped with a floating buoy, to which vessels can be secured to forestall free movement on the water.

Anchorage is permitted only at Carlisle Bay on the South Coast.

A vessel desirous of cruising or anchoring along the coast must obtain permission from the Customs Boarding Officer and the Harbour Master's office.

The request must be submitted in writing to the Harbour Master Office, Barbados Port Inc., via letter or email, preferably on arrival at the time of reporting. Subsequent contact requesting such permission can be made by contacting the **Boarding Officer** at telephone number **246 535-8822** or on **VHF Channel 16.**

Correspondence must include vessel specifications and anchorage position requested. The requested position is plotted by the Harbour Master and forwarded to Coastal Zone Management Unit (CZMU).

The CZMU then reviews and approves/denies/suggests alternate positioning.

The decision is communicated to the Harbor Master and forms the basis of the response to the request.

ANCHORAGE AT CARLISLE BAY


Only yachts of less than 150 ft in length are accommodated at Carlisle Bay.

MOORING ALONG COASTS

Requests to permit mooring must be submitted in writing to the Harbour Master Office, Barbados Port Inc., via letter or email.

Correspondence must include vessel specifications and the mooring position requested.

No yacht will be permitted to charter, rent, lease or engage in any other activities for monetary gain while visiting in Barbados.

Disembarkation Or Transfer

Any crew member of a yacht wishing to sever connection after the vessel has been cleared, must go to the Immigration Office accompanied by the Master who will indicate whether or not he approves before the Immigration Officer grants him permission to disembark.

If permission is granted for the crew member to leave the vessel, all baggage and other personal property must be taken to the Customs Officer in the Passenger Terminal for examination. The Customs Boarding Officer and the Baggage Officer must also be informed prior to any property being removed from the vessel.

Repair Facilities

Should there be the need to carry out repairs, the Master should contact Barbados Port Inc. at for the following facilities:-

- (i) Space for dry-docking on shore.
- (ii) Lifting out of the water and transportation to dock storage position.





(Marine Charges For Yachts In Port)

Vessels 50 meters & under: BBD\$412.50 for the first 2 days and BBD\$110.00 for each additional 24 hours.

Vessels 51 meters to 100 meters: BBD\$9.35 per meter for the first 2 days and BBD\$3.30 per meter for any additional 24 hours.

Vessels 101 meters and over: BBD\$11.00 per meter for the first 2 days and BBD\$5.50 per meter for any additional 24 hours.

Yachts under 50 meters berthed in Carlisle Bay pay a flat fee of BBD\$100.00.

Yachts over 50 meters berthed in Carlisle Bay pay BBD\$412.50.

For yachts calling at the port on Public Holidays, the above rates are increased by 50%.

Water: BBD\$12.00 per ton

Solid Waste Removal: BBD\$1,000.00 per skit - 1 skit=6M3

(Currency exchange rate: US\$1.00 equals BDD\$2.00)



Outward Clearance

Outward clearance is valid for twenty-four (24) hours after it has been granted.

A vessel must not however return to anchorage but must proceed from the Deep Water Harbour directly to sea and towards her next port of call.

The foregoing rates and fees are subject to revision from time to time.

An official receipt must be obtained for every payment made.

Legal action will be taken against any vessel responsible for polluting the coastal waters, or the waters of any harbour, waterway, etc.


In the event of a fire or other emergencies, the Barbados Coast Guard can be contacted immediately on VHF Channel 16, call code 8 PAPA ZULU or by telephone at 246 430 4782.

The Signal Station can be contacted on a 24- hour basis on VHF Channels 12 and 16 or by telephone at 246 434 6100 Ext. 4306.

The Master of any yacht anticipating departure from the island must endeavor to obtain the Barbados Port Inc. Clearance.

This Clearance may be obtained from the Supervisor of the Mooring Gang daily between 0500-1300hrs and 1600-2400hrs who will issue the document after being paid the anchorage /clearance fees of BDD\$100.00 in the form of a receipt.

This Barbados Port Inc. Clearance can then be presented to the Customs Officer who will then issue a final Clearance from the country.



NEW FACILITIES UNDER DEVELOPMENT

Expanded Marina

The Shallow Draught Marina has been expanded with new amenities and facilities including:

- · Construction of an additional 70 berths
- New fuel dock and fueling facility
- 2 new dedicated storage facilities to support mariners
- New Commercial Buildings (restaurant, commercial units, Fish and Farmer's Market, Restrooms, Minimart.
- •25-Ton boat lift to support vessel operations at marina
- Construction of wave attenuation structures to reduce disruption from high energy events such as winter swells and hurricanes.
- Construction of a Roll On/Roll Off dock for ferry and inter-island schooner services.
- Enhanced Road and Parking Areas
- Enhanced site utilities (potable water mains, underground HT power lines, telecom ducts).

Boat Haul-Out And Repair Facility

A new boat haul-out and repair facility in close proximity to the Shallow Draught Marina is under development under a private sector led initiative.



CARING FOR THE ENVIRONMENT IN THE WIDER CARIBBEAN

Remember proper waste management in voyage planning.

Don't discharge garbage into water except for restricted discharge of ground up food waste beyond 3 miles from land.

Don't dump oil, fuel, cleaning agents and any other such harmful substances into the water.

Yachts are encouraged to use the shore reception facilities provided, otherwise discharge sewage into the water more than 4 miles from land. Yachts with holding tanks will be given preference for anchoring closer to shore within the established anchorages.

Do not use any antifouling paints which contain organotin.

Ensure there is sufficient water depth over underwater features of nature conservation interest, such as coral reefs, when navigating close to land and in confined waters. Keel damage may occur with little impact felt on the vessel.

Ensure that the vessel is equipped with an anchor of adequate size and type together with sufficient cable or chain for the water depth encountered, seabed, weather conditions and degree of shelter to be found.

Do not anchor on corals. Use areas designated for anchoring, unless the vessel is in peril.

Take great care when going ashore as the area may be one where turtles have laid their eggs. Also avoid trampling plants, which are usually important components of the coastal ecosystem and assist in stabilizing beaches

Don't allow children, dogs or cats to run loose as sites of nature conservation interest and sensitivity.

The Government of Barbados does not allow the lighting of open fires on beaches. Permission must be sought from the National Conservation Commission at Tel: 246 536-0600 or email: ncc@ncc.gov.bb before conducting any activity on beaches involving flame.

Source current information about the wildlife and natural conservation requirements of the places you intend to visit from Customs and Immigration Services, Marinas and Tourism Information Offices.
